Outcomes from Champaign Technical Group Meeting

- Improved Pore Space Utilisation Task Force has completed its activities and disbanded.
- CCUS for Energy Intensive Industries Task Force will complete its final report in time for the next Technical Group meeting.
- Non-EHR Utilization Options Task Force will present a summary report and recommended next steps at next Technical Group meeting.

Outcomes from Champaign Technical Group Meeting

- CO₂ Hubs and Infrastructure Task Force has completed its preliminary “Phase 0” activities. Task force to continue indefinitely and present updates annually.
- Australia’s delegation will investigate the feasibility of a CO₂ Storage Reservoir Management future activity and report back to Technical Group.

Outcomes from Champaign Technical Group Meeting

- Task force was formed to explore engagement with the academic community and will report back to Technical Group with recommendations on what should happen next. Australia and United Kingdom are co-leads.
- Technical Group will inquire to the Policy Group to see if mutual interest exists for joint activities on the topic of Business Models.

Outcomes from Champaign Technical Group Meeting

- Ad Hoc Committee will continue its activities for foreseeable future and make annual reports on progress on the four priority recommendation areas from 2017 TRM.
 - “Facilitate CCS Infrastructure Development”
 - “Leveraging Existing Large-Scale Projects”
 - “Drive Down Costs along Entire CCUS Chain through RD&D”
 - “Facilitate Innovative Business Models for CCS Projects”
 - Progress toward CO₂ utilization was added as a 5th priority recommendation area.

Outcomes from Champaign Technical Group Meeting

- Ad Hoc Committee will continue its activities for foreseeable future and make annual reports on progress on the four priority recommendation areas from 2017 TRM.
 - Five working groups under Ad Hoc committee were created for this purpose (one for each of the recommendation areas, plus CO₂ utilization).
 - Working group leads to develop their own methodologies and decide the overall ratings.
