# PIRT : Terms of Reference – 1

Agreed at Technical Group in Berlin 27<sup>th</sup> September 2006



- Assess projects proposed for recognition by the CSLF in accordance with the project selection criteria approved by the Policy Group. Based on this assessment, make recommendations to the Technical Group on whether a project should be accepted for recognition by the CSLF.
- Review the CSLF project portfolio and identify synergies, complementarities and gaps, providing feedback to the Technical Group and input for further revisions of the CSLF roadmap.
- Identifying technology gaps where further RD&D would be required.
- Foster enhanced international collaboration for CSLF projects, both within individual projects (e.g. expanding partnership to entities from other CSLF members) and between different projects addressing similar issues.

# PIRT : Terms of Reference – 2

Agreed at Technical Group in Berlin 27<sup>th</sup> September 2006



- Promote awareness within the CSLF of new developments in CO<sub>2</sub> Capture and Storage by establishing and implementing a framework for periodically reporting to the Technical Group on the progress within CSLF projects and beyond.
- Organize periodic activities to facilitate the fulfillment of the above functions and to give an opportunity to individuals involved in CSLF recognized projects and other relevant individuals invited by the CSLF, to exchange experience and views on issues of common interest and provide feedback to the CSLF.
- Perform other such tasks which may be assigned to it by the CSLF Technical Group.

- All 9 countries attended

- Agreement of a 3 co-lead approach, initial countries :-
  - Australia
  - European Commission
  - United Kingdom
- Rotation of co-leads
  - 1 person changing annually to ensure continuity and opportunity for change
- Reporting
  - report to CSLF TG
- Meetings
  - most interaction through tele-conference calls
  - physical meetings held prior to CSLF meetings and at convenient times

## **Action Recommendations**

- **Key Action Recommendations**
  - (i) **Complete a comprehensive gap assessment** in 2006 with aim of identifying where CSLF projects should be encouraged in relation to CSLF Charter :
    - input from wide range of sources including TG Gap Analysis work
    - use Floating Group expertise
    - plan for follow-up workshop to Potsdam with focus on filling gaps and identifying what expertise can be brought to bear
  - (ii) **Review CSLF Project selection criteria** to ensure consistency with CSLF Charter, CSLF TRM and gap assessment action :
    - propose metrics to assess a project proposal for CSLF acceptance
    - set guidelines/process to be used within PIRT project assessment

## **Formation of Floating Group**

- **Composition**
  - representatives from CSLF projects and additional experts as required
- **Interaction with Core Group**

  - Briefing Note** from Core Group on operation of PIRT function and operation to go to all CSLF Project representatives
  - Gap Spreadsheet** to reviewed by Core Group and then sent to Floating Group for comment and input
  - Workshop preparation** : advice from Floating Group on shape and content
