1. CCS Technology Development and Deployment - *Technical Group*
2. Policy and Legal Framework
3. Capacity Building
4. Public Awareness and Acceptability
5. Involve Stakeholders
6. Collaboration with other International Organizations

## Q1. Do goals defined in the strategic plan serve the purpose of the CSLF?

### Goals of the CSLF Charter

*To facilitate the development of improved cost-effective technologies for the separation and capture of carbon dioxide for its transport and long-term safe storage; to make these technologies broadly available internationally; and to identify and address wider issues relating to carbon capture and storage. This could include promoting the appropriate technical, political, and regulatory environments for the development of such technology.*

### Goals of Strategic Plan

- 1. Identifying potential for CCS technology development and deployment opportunities.*
- 2. Promoting the deployment of full scale demonstration and pilot projects.*
- 3. Supporting development of relevant legal and regulatory frameworks.*
- 4. Identifying potential barriers to and opportunities for investment and funding to facilitate projects.*
- 5. Collaborating on capacity building with member developing countries...*
- 6. Addressing the barriers to public awareness and acceptance...*

### *Strategy 3: Capacity Building*

- ✓ The CSLF Strategic Plan should be updated to reflect progress since 2006.
- ✓ Aspects of the G8-IEA-CSLF recommendations should also be incorporated into the Strategic Plan to ensure the work of the CSLF is cohesive and complementary of the G8 process.
- ✓ This update should identify:
  - Significant achievements as strategic destinations,
  - Strategies to reach those destinations,
  - Activities to execute the strategies,
  - Priorities for each of the activities, and
  - Milestones to measure progress.
- ✓ A Task Force to do this should be created with participants from both the Policy and Technical Groups as well as Stakeholders.
